Chief Executive Eileen Curtis presented the Chief Executive's report:

Boards of Management

All new Boards of Management must be in place by 30 November 2019. Training will be provided to BOMs in November.

ETB Board

Induction Training for Board Members was provided as part of the meeting by the Institute of Public Administration. Further training will be provided in the new year.

A risk management culture must be promoted within KCETB, key elements include:

- Appointment of a Chief Risk Officer Liam Scott
- Adoption of Risk Management Policy
- Roll out of Risk Management Implementation Plan

Kilkenny Schools Campus

The Design Team are continuing to work on design options for presentation to the DES. The architect is in contract with the DES in preparation for a Stage 1 meeting. Formal approval in principle has been received from DES to proceed with the proposed exchange of lands with the Trustees of St. Kieran's College.

Administrative appointments

Earlier in the year sanction was given by the DES to fill administrative posts on a permanent basis and accordingly this process has been ongoing for a period with a number of appointments being made at different grade levels.

6.2 Schools

Director of Schools Pauline Egan presented the schools report.

Board members were informed of the school enrolment figures for 2019/20 and the subsequent final teacher allocation.

Congratulations were expressed to Junior Certificate students on their great results and hard work during the year. First year students throughout all KCETB schools are the first cohort studying all new subject specifications for Junior Cycle with technology and practical subjects being the last phase of subjects being rolled out this year.

The first of a series of teaching and learning workshops delivered by Mike Hughes took place in September with further sessions planned.

Two KCETB schools are participating in a programme Embedding Sustainable Development Goals in Teaching and Learning at Junior Cycle, the first training day has already taken place with further training planned.

- Kilkenny and Carlow ETB School Self Evaluation CPD on Leading School Self Evaluation in your School is taking place. The programme aims to support schools through the school selfevaluation process over the course of a school year. Delivered over four dates, the content of sessions includes: preparing questionnaires/ survey tools, using Microsoft Forms to gather data, collation and analysis of data, completion of the SSE Report and the School Improvement Plan (SIP) and organising and facilitating SSE Team meetings.
- KCETB Deputy Principals Network
 - An inaugural meeting of our deputy principals has taken place. The role of the network is to provide professional leadership for learning support and a forum to share best practice, collaborate and network with colleagues.
- Corporate Governance a briefing for School Leaders took place in November.

As proposed by Clare Ryan, seconded by Mary Hilda Cavanagh and agreed, the nominees were duly appointed to the respective BOMs.

It was confirmed to Board members that a schedule of Board meetings is issued at the beginning of the year and members should inform other committees or Boards they are sitting on of the dates to avoid any clash of meetings.

It was noted that Carlow County Council is a sustainability champion and would be happy to work with schools on sustainability projects.

6.3 Further Education and Training

Director of FET Martha Bolger, presented the further education and training report.

DCYA – approved the Area Profile for KCETB. This initiative sees funding from DCYA for both Ossory Youth and Carlow Regional Youth Services coming through KCETB. The Area Profile Tool is a needs assessment based on geographical areas and needs assessment of the requirements of young people.

DEASP ETB BREXIT Meeting. DEASP have been preparing for Brexit implications. KCETB attended an information briefing in October.

SOLAS - Apprenticeship Awards – Over one hundred KCETB apprentices graduated with An Advanced Craft Certificate. The ceremony was hosted by Tipperary ETB on behalf of KCETB, TETB and WWETB. The certificates were awarded in Heavy Vehicle Mechanics, Motor Mechanics, Metal Fabrication, Pipefitting, Plastering, Carpentry & Joinery, Toolmaking, Electrical, Brick & Stone Laying, Construction Plant Fitting, Agricultural Mechanics, Plumbing, Wood Manufacturing and Stone Cutting & Stonemasonry.

Internal Audit Unit. The Internal Audit Unit for Education and Training Boards (IAU - ETBs) has conducted an internal audit of Previous Internal Audit Findings in KCETB. Programmes within Further Education and Training were reviewed including: Community Education, Adult Literacy and Youthreach. In addition to these programmes, the IAU is now reviewing grant funding that KCETB grants to community bodies to provide local and community training.

South East Regional Skills Forum. KCETB attended an Education and Training Seminar with the SERSF. Institutes of Technology, neighbouring ETBs and Skillnets also attended to discuss collaborative programmes for 2020. ETBs and IOTs will collaborate on a pilot from Level 6 to Degree in Supervisory Management.

Nominations to FET Committees were received for appointment by the Board, see Appendix 2. As proposed by Noel Phelan, seconded by Mary Hilda Cavanagh and agreed, the nominees were duly appointed to the FET committees.

The board acknowledged the ongoing work of FET in the region and apprenticeship numbers are increasing.

It was recently discussed at ETBI, that all educational capital projects in excess of €1m would be facilitated by ETBs.

Finance

The income and expenditure reports for August, September and November were presented.

Overdraft facility - Proposal for an application for overdraft facility in accordance with circular letter 0066/2014

In November 2015 the Board initially approved the Chief Executive's proposal to seek permission from the Minister/DES to borrow for the purpose of carrying out the ETB's functions. The sanction received from the Minister expires on 6 December 2019. Sanction must be sought from the Minister/DES annually. The Chief Executive now proposes that the Board approve a continuation of this overdraft facility in principle and seek sanction from the Minister. This facility has not been required to date, but it is considered appropriate to have the facility in place as a matter of financial prudence.

This was recommended by the Finance Committee at its meeting on 22 October 2019. There is no charge for having the facility available unless it is required. The amount of the overdraft facility will remain unchanged.

Proposed by Mary Hilda Cavanagh, seconded by Andrea Dalton and agreed, the Board approved the CE's proposal to seek permission from the Minister/DES for continued use of the facility.

7. Risk Management

Risk Management Report

The following report is submitted by the Audit and Risk Committee;

1. Appointment of Chief Risk Officer

Section 7.2 of the Code lists the key elements of the Board's oversight of risk management. The Code requires the appointment of a Chief Risk Officer or suitable management alternative, to identify, measure and manage risk and promote a risk management culture in the organisation.

The Chief Risk Officer's responsibilities, in co-ordination with the executive management team, will include the co-ordination of risk management activities across KCETB, active management of risk registers and submission of Risk Management Reports to the Audit and Risk Committee and Board. The Audit and Risk Committee recommend the appointment of Liam Scott (KCETB Director OSD) as Chief Risk Officer in KCETB.

2. Risk Management Policy

The committee recommend the Risk Management Policy to the Board of KCETB, this policy sets the appetite for risk management in the organisation and is based on a template for all ETBs.

3. Risk Management Implementation Plan

KCETB's Risk Management Implementation Plan sets out the plan to achieve the objectives of KCETB's risk policy. This document is an active working document and subject to modification to ensure risk is managed appropriately in KCETB.

The Audit and Risk Committee recommend the adoption of the Risk Management Implementation Plan as a document subject to ongoing modification which will facilitate an appropriate and effective system of risk management in KCETB.

4. Risk Registers

The Committee reviewed the risk registers presented in their current iteration. The registers will be updated on an ongoing basis in consultation with management and staff. It was suggested by the committee to include a risk owner on the register. Reviews of the risk register will take place at each Audit and Risk Committee meeting.

The committee recommend the Risk Register to the Board. The Risk Register is available for all Board members at any time. It is proposed to furnish a copy of the latest version of the register following comment from the Audit and Risk Committee.

5. Other Policies

The Audit and Risk Committee have a duty to advise the Board on;

- Anti Fraud and Corruption policy;
- Protected Disclosures policy;

The Audit and Risk Committee review such policies and advise the Board accordingly.

Financial Authority and Approval levels
