Conflict of Interest

At the start of the meeting, the Chair reminded members about procedures for dealing with any potential conflict of interest arising during a board meeting:

The ETB Act of 2013 and the Code of Governance (2015) both state that a member of an ETB board must absent himself/herself when the board is deliberating or deciding on matters in which that member has an interest. He/she should not take any part in any deliberation of the board relating to the matter, should not influence, or seek to influence, a decision to be made in relation to the matter and should not vote on a decision relating to the matter.

1. Appointment of Chief Executive

- The appointment of a Chief Executive is a reserved function of the board [Section 12 (2)(b) ETBA 2013]
- II. The Public Appointments Service on behalf of the Department of Education and Skills held a competition for the purpose of recommending a person for appointment to the position. The recruitment schedule was as follows;
 - a) The Public Appointments Service advertised the position on 11 October 2018
 - b) Closing date for completed applications was 1 November 2018
 - c) The selection process was undertaken by the Public Appointments Service and the name of the candidate recommended for appointment was then furnished to the Department of Education and Skills.
 - d) The Department of Education and Skills notified the name of the candidate recommended for appointment to the ETB on Monday 11 February 2019
