#### 6. Chief Executive's Report

Chief Executive Eileen Curtis presented the Chief Executive's report:



#### 6.1 Corporate Governance and Administration

#### **Student Enrolment**

Following completion of the October Returns to the DE and DFHERIS the second level student enrolment is 5,276 across the 13 schools for the school year 2022/23 and the number of FET starters is 11,004 to date for 2022.

#### Training for Chairperson and Secretary to Boards of Management

It was noted that a webinar to support members in their governance role would take place on 30 November. This is an online event hosted by ETBI which will focus on promoting good practice for Chairpersons and Secretaries. Registration details to follow and all members undertaking the role of Chairperson were encouraged to attend.

#### **Financial Shared Service**

The transition to the SUN Financial System took place in January and training is continuing for school and centre staff. Discussions are ongoing in respect of the engagement of ETBs with the serviced provider ESBS. In addition, discussions are taking place regarding the sequencing of further elements of the shared services project.

#### Administration

Discussions are ongoing with the DE/DFHERIS in respect of staffing and progressing a fit-for-purpose organisation design for ETBs and for long-term workforce planning for core corporate services and for Further Education and Training. These discussions are critical for the further development of services. Sanctions have been received for the renewal of a number of posts in FET.

#### Awards/Retirement Functions

A series of awards ceremonies have taken place in schools and centres to celebrate the work of students on receipt of their certificates. KCETB hosted the Regional Apprenticeship Awards on 17 October with 362 apprentices receiving their certificates.

A function to recognise the service of retired staff took place on 24 October to acknowledge the contribution of these staff to KCETB.



#### **Ukrainian Education Supports**

A new REALT Co-ordinator has been appointed to support the provision of education services across KCETB. The DE is due to communicate with ETBs shortly in respect of the continuation of education services for Ukrainian refugees through the REALT Teams. Ukrainian nationals are continuing to arrive with additional accommodation being sourced locally on an ongoing basis. Work is continuing with the provision of educational services for Ukrainian children and adults. Capacity in schools in Carlow has not been an issue to date, while primary school capacity in Kilkenny is full with very limited capacity at post-primary level. This has resulted in additional enrolment in schools outside the city area.

There are currently 206 students enrolled in primary schools, 71 in Carlow and 135 in Kilkenny. At post primary level there are 159 students enrolled, 52 in Carlow and 107 in Kilkenny.

English language classes continue to be provided at a number of locations with adults attending, 286 in Carlow and 417 in Kilkenny.

#### 6.2 Schools

Director of Schools Pauline Egan presented the following report:

#### Teaching and Learning

- Annual TEACH MEET our professional learning and sharing event took place virtually on 6 October. 231 teachers attended the event.
- All schools are in the Admissions Process for enrolment for 2023/24. Most schools
  closed their three-week window on 24 October and now have two weeks to issue the
  offer of places.
- The Final Induction for new teachers to the scheme takes place on 28 November being delivered by Dr. Joe O'Connell. The theme of this session is Effective Communication and Building Positive Relationships in the school community.
- Student Councils Training for Student Councils on promoting and supporting student voice and leadership took place on 20 and 26 October. 145 students together with their link teachers attended.
- ETBI Ethos Project The first meeting of our Professional Learning Network for 2022/23 took place on 27 October facilitated by our Ethos Co-ordinator Conor Walsh. All thirteen Ethos Lead Teachers (ELTs) from our schools were in attendance.



- 12 teachers are involved in a Community of Practice for Integrating Restorative
   Practices training into professional practice which began on 13 October. The
   programme is delivered over 7 sessions running from October 2022 to April 2023.
- Digital Strategy for Schools The KCETB TeachNimble Programme being delivered by Dr. Michael Hallissy from H2 Learning will run from January to end March 2023. This 10-hour blended learning programme will be run for 5 sessions over 8-10 weeks in the Spring.
- Teaching and Learning Workshops Magenta Principles A series of three workshops to enhance teaching and learning in our schools will continue this academic year 2022/2023. Thirty-two teachers are attending with the second workshop taking place on 29 November.

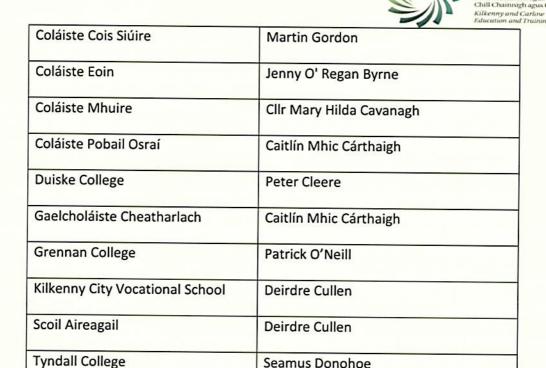

#### Governance and Management

#### **SOLAS Capital Applications:**

SOLAS Parameters for Planning: Documentation for 2023 has been received and all centres are being asked to schedule courses for 2023 from November.

Leases: Purcellsinch - Lease Unit M has been completed and fit out and scheduling of classes at Unit 6 Danville is under way.



**PLC Enrolment:** The PLC Census date was 14 October. An internal census in both centres was taken on 11 and 12 October last.

**Community Education:** A workshop was held for representatives of Community Groups in Kilkenny and Carlow to provide an overview of Community Education provision and services. Approximately 120 people attended on 25 October. An overview of the Statement of Strategy for KCETB was given as was information on the data required from groups to support funding.

SOLAS are hosting the launch of the Community Education magazine and report on Wednesday 7 December. Community Education Service Kilkenny has been invited to talk about the ongoing



work that they do, in particular with Kilkenny Brain Works Group and about the Christmas Wreaths projects and their proposals for this year.

#### Other:

**DCEDIY Visit:** Dingfen Zhong (Assistant Principal, Youth Affairs Unit) visited KCETB in October. She met with the CE, DFET, AEO and Youth Officers and then attended UBU schemes in Kilkenny and Carlow.

**COACH TTC LAUNCH:** On 19 November, the Traineeship in ECO Driving for Bus and Coach Drivers will be launched. This is a result of a joint collaboration between KCETB and MSLETB and personnel in the Training Services are to be congratulated on their work.
