1. Conflict of Interest

2. FET College – Final Business Case: Next Steps

FET College – Final Business Case and Next Steps

It was noted that the rationale for a College of FET in Kilkenny was initially set out in the Strategic Assessment Report submitted in April 2022 and was further developed in the Preliminary Business Case submitted in January 2024. A summary of the Preliminary Business Case was circulated to board members which outlined the rationale and case for the recommended proposal to purchase a green field site for the construction of a purpose-built College of FET in alignment with national, regional and local strategic plans and learner needs.

The process for the completion of a Site Selection Report was outlined and included consultation with Kilkenny Co. Co., SOLAS and DFHERIS culminating in a submission in July 2023 on the sites considered, with the identification of a number of site options for further assessment and consideration, one of which has since been ruled out due to due diligence risks. It was noted that in advancing this proposal KETB has liaised with both SOLAS and DFHERIS and has complied with all the regulatory requirements under the Public Spending Code and other relevant circulars and guidelines.

The current site option was outlined, and it was noted that KCETB have retained legal representatives to assist progress.

Th approval of the board was sought to engage in the process of site purchase in line with SOLAS and DFHERIS approvals and ministerial consent. This was proposed by Michael Delaney and seconded by Mary Hilda Cavanagh and agreed.
