1. Conflict of Interest

At the start of the meeting, the Chairperson reminded members about procedures for dealing with any potential conflict of interest arising during a board meeting:

The ETB Act of 2013 and the Code of Governance (2019) both state that a member of an ETB board must absent himself/herself when the board is deliberating or deciding on matters in which that member has an interest. He/she should not take any part in any deliberation of the board relating to the matter, should not influence, or seek to influence, a decision to be made in relation to the matter and should not vote on a decision relating to the matter.



2. Consideration of the appointment of recommendation for the post of Acting Chief Executive

Consideration of the appointment of recommendation for the post of Acting Chief Executive It was noted that KCETB invited applications from suitably qualified members of staff employed by Kilkenny and Carlow ETB for the post of Acting Chief Executive on a temporary basis for a sixmonth period or until a permanent Chief Executive is appointed to Kilkenny and Carlow ETB, whichever is earlier with effect from the 1 April 2025, following approval from the Department of Education.

This post was advertised on 10 February 2025, with a closing date on 21 February 2025. Interviews were held on 7 March and the interview panel recommended Dr. Pauline Egan for the post of Acting Chief Executive.

This recommendation was approved by the board, proposed by Fergal Browne, seconded by Madailín Mhic Lochlainn and agreed.

Congratulations was extended to Pauline on her appointment and grateful thanks was extended to all applicants for the position.
