6. Chief Executive's Report

Chief Executive Eileen Curtis presented the Chief Executive's report:

6.1 Corporate Governance and Administration

The following were noted:

Service Plan

Under the requirements of the Education and Training Boards Act 2013 and the Code of Practice for the Governance of ETBs 2024, the board is required to adopt the Annual Service Plan for submission to the DE prior to 1 March. The Finance Committee have a role in reviewing the draft of the Service Plan and did so at their meeting on the 14 February. The KCETB Service Plan for 2025 was circulated to members and a presentation made by the CE.

Annual Financial Statements 2024 (AFS)

The adoption of the AFS is required by the Act and the Code also and requires that the board adopt the ASF prior to submission to the DE by 1 April. The accounts are currently in preparation for the ETB meeting on the 18 March.

ETB Week

ETB Week will take place from 24 - 28 March with ETBs across the country invited to submit awards under a series of categories, as well as undertake events to promote our services. The launch of an ETBI publication about ETBs will also take place on the 26 March. The KCETB article on restorative practice was prepared by Pauline Egan, Director of Schools.

FET Updates

It was noted that a meeting took place with SOLAS on capital developments on 24 January and a planning meeting is due to be scheduled regarding future planning and funding for 2025. It was also noted that work is ongoing in respect of the accounts and the outturn for 2024 with the position substantially improved due to additional funding and revisions taken at local level. Further engagement with SOLAS will take place in respect of 2025 service delivery.



Ukrainian Educational Provision

Enrolment figures were provided as was a full update on KCETB services and networking with other agencies in the provision of services to Ukrainian and other international protection refugees. The REALT Steering Group continues to meet and demand for places has been met to date.

6.2 Schools

Director of Schools Pauline Egan presented the following report:

Teaching and Learning and Assessment

A webinar for KCETB Schools on the use of Artificial Intelligence in Education took place on 28 January. 80 were in attendance. This webinar was delivered by Áine Byrne, PD and TEL Office.

Certificate in Restorative Practice

This programme running over 12 weeks, started on 10 January 2025 and is a collaboration between Kilkenny and Carlow ETB and SETU Carlow. 16 teachers and SNAs are engaged with the programme.

ETBI Annual Principals and Deputy Principals Conference took place on 30 and 31 January 2025 and the theme of the conference was Leadership for Excellence.

KCETB Guidance Counsellor Professional Learning Event takes place on 25 February 2025. The session will provide updates on PLC Programme and FET Options for 2025/2026.

ETB Week – takes place 24 to 28 March.

Details of the award areas recognising excellence, innovation and inclusion were outlined.

ETBI Induction for Newly Appointed Principals and Deputy Principals takes place 6 March 2025.

KCETB Principals and Deputy Principals Spring Conference takes place 13 and 14 March 2025 in Portlaoise and the theme of the conference this year is Leadership for Change.

Human Resources

Applications in relation to job-sharing, career break and transfer for teaching staff closed on 1 February 2025. There were 36 Job Sharing applications, 23 Career Break applications and 8 Transfer applications for schools for the 2025/2026 academic year.

6.3 Further Education and Training

Chief Executive Eileen Curtis presented the following report:

Governance

Capital Planning

A meeting took place with SOLAS on 24 January to review capital projects and expenditure for 2024 and plan for 2025. The discussion focused on utilisation of Project Management Services, observance of governance and financial requirements, and adherence to programme guidelines, particularly for funding draw-downs. KCETB was commended for their adherence to guidelines and reporting.

Devolved Capital

KCETB's 2025 Devolved Capital Grant (DCG) is €435,000. This is a fixed figure at the same level for the years 2024-2026 to allow for improved planning and expenditure.

The Green Devolved Capital Grant is also €435,000.



Grennan Mill

A review of the Mill building is in progress, with a view to scoping a plan for future use. This will involve consultation and identification of options.

Audit and Risk Committee

The Director of Further Education and Training met with the Audit and Risk Committee on 7 February. All centres have completed the Assurance Checklists.

2025 Financial Allocation

No budget or teaching allocation has been received to date.

Review of KCETB Website

Following the Managing Authority's information session in October 2024 on Communication Compliance for the current EU programme, i.e. EIST 2021-2027, SOLAS conducted an initial review on Kilkenny and Carlow ETBs' website. This review was to ensure compliance with the current requirements. Websites and social media updates have been made following recommendations.

EIST Upload & Declaration

Non-financial declarations have been created on the new IEFAS system for Adult Literacy and Youthreach to assist reporting on the EU funded aspects of these programmes.

Quality Assurance

The Interim Quality Report has been submitted as has a progress update on KCETB's inaugural review follow-up report.

DSP Central Co-ordination Group

This group meets 2/3 times per year. The group comprises of FET Senior Management representatives and senior DSP staff. The group recommends programme provision and engagement initiatives for DSP clients. The group is part of a wider DSP ETB protocol agreement working to improve the employability of Social Welfare clients.

Teaching and Learning

Adult Literacy

The Adult Literacy for Life Collaboration and Innovation Fund closed for applications on 7 February and details of the partner applications was provided.

1. Kilkenny Schools Campus

- a. The Archeological Survey Report has been submitted to both Kilkenny County Council and the National Monuments Service.
- b. The Enabling Works Construction Contract should be issued this week with works scheduled from March to September 2025.
- c. The construction pre-qualification competition is going back to tender as an adequate number of providers did not qualify.

2. Gaelcholáiste Cheatharlach

d. The Stage 2A Developed Sketch Scheme report was forwarded to the DE in February.

3. Coláiste Mhuire, Johnstown

a. The Stage 2B Detailed Design report was submitted to the Department on 11 October and the project has been sanctioned to proceed to planning.

4. Grennan College, Thomastown

- a. Construction of the new modular unit to provide general classrooms has commenced and is scheduled to be operational by March.
- b. Approval has been received for the provision of a static water storage tank to comply with fire safety requirements.



c. The Design Team are working on the Stage 1 Preliminary Design report for a substantial extension with a presentation due by the Design Team in February.

5. Duiske College, Graignamanagh

- Discussions on ongoing regarding possible temporary accommodation to facilitate work on the existing school site and other options are also being explored.
- b. Gas and general emergency works are ongoing and an application for electrical upgrades has been submitted.

6. Borris College

- a. The Design Team have submitted the Stage 2A Developed Sketch Scheme report for additional accommodation to the Department.
- b. Roof repair emergency works are ongoing.

7. Coláiste Eoin, Hacketstown

- a. Roof repair emergency work is scheduled to be completed in March.
- b. The design team met on 29 January and site surveys are due to commence.

8. Kilkenny City Vocational School

a. The building contractor for the site safety project is being appointed with the work scheduled for completion by April 2025.

7. Draft Service Plan

As part of the Performance Delivery Agreement between ETBs and the DE, a section of the Service Plan details the priorities of the ETB and the measurable targets to be achieved in 2025. As detailed in the Code of Practice for the Governance of ETBs 2024, the Finance Committee have the responsibility of reporting to the Board on the Draft Service Plan. The Finance Committee met on 14 February 2025 and recommended the adoption of the Service Plan to the Board.



The CE provided an outline to members on the key priorities and actions for achievement in 2025 across each of the directorates and highlighted specific KCETB priorities. The Service Plan sets out the expenditure in line with the Letter of Determination received from the DE.

The Board thanked the executive for their work and for the preparation of the Service Plan 2025. The Plan was proposed by Mary Hilda Cavanagh, seconded by Fergal Browne and agreed, and accordingly adopted by the Board of KCETB.
