6. Chief Executive's Report

Chief Executive Eileen Curtis presented the Chief Executive's report:

6.1 Corporate Governance and Administration

Annual Financial Statements for 2024

It was outlined that the KCETB Annual Accounts for 2024 have been completed and will be submitted to the C&AG by the deadline of 31 March 2025, subject to board approval. Thanks was extended to all staff who have collaborated in the process, and to the Finance and Audit and Risk Committees for the role they play in ensuring that KCETB upholds high standards of governance.

It was also set out that the statement of internal control for 2024 would be signed by the Chair and submitted with the accounts. The statement is based on the assurances provided by the Finance and Audit and Risk Committees in their reports to the Board and all relevant matters have been included in the Statement of Internal Control.



Annual Report 2024

It was noted that a draft Annual report is being prepared and will be presented to the board for adoption as is the requirement under the Code of Practice for the Governance of ETBs. A draft copy will be circulated in advance of the next meeting, and should members wish to suggest any relevant amendments or have any queries at that stage they may do so.

FET Updates

College of FET Kilkenny

A meeting took place with the SOLAS Capital Team in respect of the refinement of the FET College Business Case in preparation for final publication.

FET Budget 2025

SOLAS have advised that the indicative budget will issue at the end of March with all aspects finalised by the end of May. Provision will be aligned with the approved budget

Kilkenny Schools Campus

The enabling works contractor is about to commence on site to complete the enabling works in respect of ESB, water and other services, and the first meeting took place on the 6 March. A groundbreaking ceremony took place in respect of the works in advance of the meeting.

A further meeting took place with DE personnel in respect of the Stage 2b report on the 11 March with further submissions to be made by the end of March.

The process for the appointment of the main contractors has commenced.

ETB Week

A number of nominations have been submitted for various award categories and the outcome is awaited from ETBI in respect of same.

Ukrainian Educational Provision

Enrolment figures were provided as was a full update on KCETB services and networking with other agencies in the provision of services to Ukrainian and other international protection refugees. The REALT Steering Group continues to meet and demand for places has been met to date.



6.2 Schools

Director of Schools Pauline Egan presented the following report:

Teaching and Learning

KCETB Leadership Programme for middle leaders (Assistant Principals/AP1's) continues this term with Dr. Joe O Connell.

KCETB Guidance Counsellor Professional Learning Event took place on 25 February 2025. The session was delivered by the Further Education and Training team who provided updates on PLC Programme and FET Options for 2025/26. A presentation on the Tertiary Programmes available was outlined also. 24 attended the event.

ETB Week - takes place from 20 to 24 March

ETB Week provides an opportunity to promote and celebrate our ethos and our continued promotion of excellence in education. Local events will take place in schools and be promoted through social media platforms. The KCETB Schools Debating Competition is currently taking place with further rounds to be held during ETB week in celebration of student voice in our schools.

ETBI Induction for Newly Appointed Principals and Deputy Principals took place on 06 March 2025.

The KCETB Principals and Deputy Principals Spring Conference took place on 13 and 14 March. The theme of this year's conference was *Leading Change*.

ETBI SEN Mapping Schools Project

This project supports schools to set out the provisions and interventions available to students along the continuum of support. It provides a basis to strategically plan provision, allocate resources and identify staff CPD needs.

A Community of Practice has been established for the Special Education Needs Co-ordinators (SENCOs) in our schools with the next session on 20 March.

Governance and Management of Schools

Inspections

 Kilkenny City Vocational School – final report issued for the Programme Evaluation (LCA) that took place in December 2024.



 Coláiste Cois Siúire – final report issued with regard to their Special Education Needs Evaluation.

New Model of DEIS Inspection – DEIS Plus – Kilkenny City Vocational School welcomed the Department Inspectorate to their school the week beginning 3 March to engage in a research lead pilot inspection on the new DEIS model of Evaluation. This was a very positive experience for all involved and all in the school community were delighted to have achieved outstanding in the quality framework. School Management were also thrilled to have their work on integrating national policy into classroom practice particularly acknowledged.

Boards of Management – An ETBI Webinar took place on 11 February on "Meeting the needs of Children and Young People with Special Education Needs in primary and post primary schools: An introduction for Boards of Management."

Human Resources

The Initial Teacher Allocation for 2025/26 has issued and schools have been working on their curricular appeals applications which were submitted to the Department of Education by 12 March.

Letters have issued to teachers with respect to their job share and career break applications. Application forms and circulars in relation to job-sharing, career break and transfer for Special Needs Assistants closed on 1 March 2025.

6.3 Further Education and Training

Director of Further Education and Training Martha Bolger presented the following report:

Capital

College of FET Kilkenny

A meeting was held on 3 March with the capital team in SOLAS in respect of feedback on the Business Case. This feedback is being considered, and any clarifications/advice will first be incorporated into an addendum document and following agreement will be incorporated into the final version of the Business Case.

Grennan Equestrian Centre

Philip Doyle, Buildings Officer, has being working with the design team to prepare information for the Further Information request. This has involved consideration of the alignment of the sight lines at the current entrance with some reconfiguration of the arena.



2025 Financial Allocation

No budget or teaching allocation has been received to date.

Recruitment

Recruitment for a Senior Training Advisor is currently taking place.

REACH Funding

The 2025 REACH funding guidelines have been received. The initial Reach funding allocation for KCETB is €225,000. To date €180,000 in applications have been approved.

DEIS to FET Annual Guidance Counsellor Event

This event took place on 25 February in Carlow, where Guidance Counsellors from KCETB schools were updated on the programmes on offer for Leaving Certificate students.

Presentations were delivered on full- time Level 5 & 6 programmes, apprenticeships and degree programmes.

AONTAS Learner Forum

KCETB in collaboration with AONTAS hosted a Learner Forum on 11 March. This event, is part of a suite of events organised for ETB Week and was attended by 100 learners representing all FET programmes.

Heritage Council Collaboration

On 7 March, both KCETB and the Heritage Council hosted an open event at Sheepstown, Kilkenny to invite interested parties and media to view the Thatching programme. The programme aims to skill participants in thatching and thatching techniques in response to a request from the Heritage Council. This one-of-a-kind programme is being commended nationally and will provide further evidence to support KCETB's application for a centre for Specialist Conservation Skills as part of the College of FET Business Case.

Youth Office

Applications from both Ossory Youth and Carlow Regional Youth Service for monies under the Resilience and Effectiveness Fund for 2025 have been assessed with both receiving €10,000.

Correspondence received from DCEDIY has indicated that the ETB Youth Grant for 2025 is €289,023. This represents an increase of 4% to the overall funding allocation for 2025.

Apprenticeship EXPO

On 6 March KCETB hosted its second Apprenticeship Exhibition. This exhibition featured a large range of national and regional companies as well as consortia who are currently recruiting for apprentices. The event was booked out in advance with over 1200 people in attendance on the evening.



Final update on 2024 Strategic Performance Agreement (SPA)Targets

A full update on the SPA targets was provided with further work required in the area of Key Skills.
